Namulonge, long/lat 0° 31' 47" North, 32° 36' 9" East

2. Is this an urban or rural area and how many people live in this specific area?

Rural area, population 400.

3. Is this a high risk malaria area? If yes, why do you designate it as high?

Yes. This is a high rate of cases of malaria in this village. CDC lists it as such. The WHO has designated the interior of Uganda as having high rates of morbidity from malaria.

4. How many *reported* cases of malaria and malaria deaths were there in this area in 2005? If you do not have statistics please make a qualitative comment.

There are no statistics but I have spoken to the midwife in the village and she has said "the people (and children) come all day everyday to the clinic with fever and sickness".

5. Is this distribution of nets 'blanket coverage' of an area/village or to a select/vulnerable group? If the latter, please describe this group.

Blanket coverage for the village of Namulonge.

6. What is the existing level of ITN use in this area? Are there existing bednet distribution programmes in this area?

None, no.

7. Why was the area/villages chosen for bednet distribution and who made this decision? Please provide the name, position and organisation of the person/s making the decision.

There are huge needs of all kinds in this village, we are also doing other humanitarian work in this area such as

digging wells for clean water, providing supplies for the clinic and educational outreach.

8. Have you consulted with the National Malaria Programme in your country about this distribution and what was their response? Please provide the name, position and contact details of the person/s with whom you have liaised.

AMF liaising with them on our behalf.

9. Please describe any pre-distribution activity, in particular how the size of the target group and number of nets required will be ascertained?

We will collect the LLINs in Kampala. Our group will be arriving in Kampala On November 23rd, 2008. We will be able to pick them up and deliver them by truck to the village of Namulonge. We will then begin distributing and helping with the hanging of them in the homes of the villagers.

10. Please describe how the bednets will be distributed, by whom, whether distribution will be a focussed effort or part of a combined programme and if there will be an information/education component to the distribution? Please indicate over what time period (typically, the number of days or weeks) the distribution will occur.

They will be brought to the village by truck. There will be a group of 10 or more people from Project Restore along with volunteers from the village to ensure every man woman and child receives a net and those that need help with putting them up will have two or more people assist with that. We will be documenting the distribution by photography and we will keep a list of the names of those who receive LLINs.

11. What post-distribution follow-up is planned to assess the level of usage (hang-up percentage) of the nets? How long after the distribution will this assessment take place? Will you provide us with the findings? What will you be able to do subsequently to increase net hang-up if relevant?

We will ensure all nets have been hung before we leave the village. Yes, we will provide you with the final assessment.
